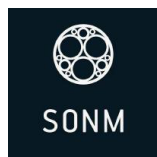

ScriptDrop is active in New York now but expanding into other areas soon. They have created a system for med reminders that help pill takers remember to take their pills. The project is live with a pharmacy system that has 1,200 pharmacies, growing to 13,000 independent pharmacies. Over 25% of patients never bother to pick up the medicines prescribed to them. The cost of picking and storing the medicine and then putting it back was \$300 million and offering a simple delivery service was the best way forward. The team uses local couriers to pick up and drop off the meds.
